



**RHI SPORTS PROGRAM SOCIAL DISTANCING AGREEMENT AND COVID 19 WAIVER**

The Rehabilitation Hospital of Indiana and the RHI Sports Program (“RHI Sports”) has put in place preventative measures to reduce the spread of COVID-19; however, RHI Sports cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending an RHI Sports event could increase your risk and your child(ren)’s risk of contracting COVID-19.

- As a participant or attendee, I understand it is my responsibility to maintain 6 feet of social distancing while participating in or attending an RHI Sports event.
- As a participant or attendee, I agree to obey and adhere to any social distancing requirements or limitations for social distancing set by RHI Sports.
- As a parent of a child participant or attendee, I understand and agree it is my responsibility to assure my child(ren) adhere to the 6 feet of social distancing at the event.
- If there is a line for any purpose I agree and understand that 6 feet of distance must be maintained from the person in front.
- I agree to not congregate in the parking lot unless 6 feet of distance is maintained from other persons who are not family members.
- If I have a child who is between the ages of 10-17 who will come or participate in the event with or without me, I certify my child and I have discussed social distancing and understand the importance of maintaining 6 feet from other individuals.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending an RHI Sports event and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at RHI Sports may result from the actions, omissions, or negligence of myself and others, including, but not limited to, RHI Sports employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself relating to or arising out of COVID-19 , including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)’s attendance at RHI Sports or participation in RHI Sports programming (“COVID-19 Claims”). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless RHI Sports, its employees, agents, and representatives, of and from any COVID-19 Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any COVID-19 Claims based on the actions, omissions, or negligence of RHI Sports, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any RHI Sports program event.
